Terms & Conditions

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Participants of the Promotion agree to be bound by these terms and conditions.

Promoter: Wavin Ireland Limited

Eligibility:

Offer open to all residents of the Republic of Ireland aged 18 and over who are recognised customers of a participating builders and plumbers' merchant. The promotion is not open to employees and families of the Promoter and its affiliate companies, its participating distributors, agencies and anyone professionally connected with the promotion.

Participant must register and have internet access to participate.

Promotional Period:

The promotion shall run in participating outlets between 14th November and 18th December 2022.

How to enter:

Participants must be a recognised customer of a participating builders and plumbers' merchant during the Promotional Period. Participating builders and plumbers' merchants will display 'Win with Wavin' promotional material throughout the Promotional Period. Promotional tickets will be supplied with any purchase of Wavin or Wavin Hep2O product and are subject to availability. To participate, participants must register online at www.winwithwavin.ie and complete a simple questionnaire. Once registered, the participant will have the opportunity to spin the wheel for a chance to win. Participants can only spin the wheel once for a chance to win one prize online throughout the promotional period and all prizes will subject to availability.
